TERMS & CONDITIONS:

1. Service Guarantee

KnotsbyAMP guarantees its services up to but not to exceed the photographic fees paid by the client. Services include digital photography & cinematography of the above wedding event by KnotsbyAMP at the above specified date and

place for the agreed amount of time.

2. Delivery

The following timelines are suggestive and not binding.

The above delivery timelines would be taken into account, from the date of receipt of the final balance payment, and not from the date of the wedding event.

The photographs would be shared through a password protected gallery. The Client is requested to download all the deliverables as and when shared.

All photography copyright © is reserved by KnotsbyAMP and its intellectual. KnotsbyAMP and its creatives reserves the right to use any photographs taken during the event for editorial and self-promotion purposes which may include print or digital media. The event may be posted on the KnotsbyAMP website with samples from the wedding and/or used for promotional and marketing materials, without mentioning the names of the clients. If there is any objection to any particular photo being used on the website or social media, the client must duly inform KnotsbyAMP in writing via e-mail to mail@knotbsyamp.com. However, KnotsbyAMP reserves the right to submit any image for any national or international photography competitions and discretion to decide on how a photograph is to be used or displayed anywhere.

3. Cancellation

Should an event be canceled due to any circumstance or unavoidable circumstances such as an 'Act of God', KnotsbyAMP and its proprietor reserve the right to keep booking fee made by the client. The client may request a full "opt out" of the agreement, half the total amount which is the booking amount will be retained by KnotsbyAMP to cover for the cost and damages due to loss of work, arrangements made in form of hiring resources and hire/purchase equipment for client's event as once the advance is received KnotsbyAMP exclusively blocks the date for client's event . The retained amount in case of a cancellation of event or opting out of the agreement on due notification before 2 months of the event (not including Act of God) will act as credit for the client which he/she/they can avail in other photography services offered by KnotsbyAMP or its Affiliates

4. Failure to Perform

If KnotsbyAMP cannot perform this agreement due to the reasons including sickness, injury, casualty or any other emergency but not limited to any other causes beyond the control of the parties, then alternate suitable arrangement shall be made with due notification and approval from the Client. KnotsbyAMP makes best efforts to prevent any damage/ camera malfunction however it shall have no liability in the event where photographic materials are damaged in processing, lost through camera malfunction, or otherwise lost or damaged without fault on the part of the Photographer. In the event of complete data loss KnotsbyAMP, will return the money. No specific photograph is guaranteed. Notwithstanding anything in this agreement, in the event KnotsbyAMP discontinues its operations prior to performance of services as entailed in this agreement, KnotsbyAMP shall make alternate arrangements towards fulfillment of services as mentioned in the agreement or shall return the advance booking amount and will have no further liability.

5. Client Usage Rights

The Client is granted unlimited usage for an unlimited amount of time of all photographs for private and personal use only. Client is free to share the images with friends and family and make as many copies as he desires.

6. Safe Environment for Work

The responsibility to provide safe working conditions, at all times; and provision for separate, hygienic and suitable accommodation for outstation assignments rests with the client. In case KnotsbyAMP employees/creatives are threatened with physical harm/abuse, they deserve the right to leave the venue without any further liability towards performance of event.

7. Other Terms:

1. KnotsbyAMP and its creative have full freedom to go about their work. By hiring KnotsbyAMP the client agrees that he/she/they has/have done sufficient research and likes/like the style and workings of KnotsbyAMP. All requests regarding photography should be communicated in advance before the event.

2. All the permits and licenses for the performance of photography & cinematography in the wedding venue needs to be arranged by the Client.
3. KnotsbyAMP team members would not be going to each and every person present at the engagement/wedding to take their photos and videos. The shoot will be done in the contemporary style, where priority would be given to the bride, groom and their emotions, rituals and the stories from the day. The onus of getting the group pictures of all the relatives, friends and other important members, if needed lies on the Client.
4. Family and friends of the client shall be permitted to photograph the engagement/wedding as long as they don't interfere with the Photographer's duties and come in between them.
5. RAW as well as processed data will be saved at our ends for a maximum of 6 months.
6. The shoot for us starts and ends at the wedding venues unless discussed otherwise.
7. Any last-minute requests for extra coverage/beyond acceptable hours will be charged at Rs 10K/hour for photography and Rs 10K/ hour for cinematography.
8. Any expenses incurred towards the performance of the shoot needs to be reimbursed by the Client.
9. Travel, Accommodation (outstation shoots) and Food Expenses for the team needs to be borne by the Client.
10. Accommodation for the team needs to be provided, if it's a wedding venue in the outskirts of the city. If there is less than 9 hour gap between two days' events, accommodation needs to be arranged by the client for the team.

BY SIGNING THIS CONTRACT, ALL PARTIES AGREE TO ALL TERMS AND CONDITIONS SET FORTH IN THIS AGREEMENT, INCLUDING THE NON-REFUNDABLE NATURE OF THE RESERVATION RETAINER AND ALL OTHER PAYMENTS MADE. FAILURE TO RESPOND WITHIN 15 DAYS OF THE RECEIPT OF THIS AGREEMENT WILL BE TAKEN AS YOUR ACCEPTANCE. SERVICES AVAILD FROM KNOTSBYAMP WILL BE AS PER SCOPE OF THE WORK & THE TERMS AND CONDITIONS MENTIONED IN THIS AGREEMENT.
